# **Diva/Don Guidelines for Nominations**

## **General Eligibility:**

- 1. Statement regarding how the nominator knows the nominee.
- 2. Statement summarizing why the nominee should be selected.
- 3. Describe the nominee's professional role.
- 4. Describe the nominee's most important contributions to nursing.
- 5. Evidence to document contributions to nursing
- 6. Identify other awards and distinctions.
- 7. Summary of significant professional positions held.
- 8. Provide a summary of educational credentials.

<u>Categories for Nominations</u> for the *Diva/Don Award* include Professional Registered Nurses who meet one of the following:

## 1. Administration

Nominees in this category will have demonstrated exceptional management of nursing and/or patient care services, such as:

- Demonstrated leadership expertise in the administration of nursing services.
- Developed and utilized a sound fiscal management program.
- Developed an effective nursing administrative system.
- Integrated a nursing theoretical framework into a nursing environment.
- Mentored and incorporated novice nurse administrators into an environment supportive of learning role responsibilities associated with emerging roles of nurse administrators.
- Implemented a nursing theoretical framework.

## 2. Advancing and Leading the Profession

Nominees in this category will have strengthened our profession in direct patient care, management, policy, or the various levels of teaching or research, such as:

- Recognized for their influence beyond their primary employment setting.
- Demonstrated leadership expertise in the nursing profession.

## Advancing and Leading the Profession continued

- Committed to the development and implementation of practice standards through the ongoing acquisition, critical application and evaluation of relevant knowledge, attitudes, skills, and judgments.
- Applied competent and ethical nursing practice beyond their primary employment setting.
- Created an environment that enhances the image of nursing and nurses.
- Influenced leadership in nursing through visionary and innovative approaches.
- Received local, national, and/or international recognition as a nursing leader in education, practice, research, and/or administration.

## 3. Clinical Care

Nominees in this category will have demonstrated excellence in direct care delivery in any clinical setting.

- Created an environment fostering evidence based exemplary clinical. practice.
- Demonstrated leadership expertise in the clinical care setting.
- Committed to the implementation of the Standards of Practice and Standards of Professional Performance.
- Applied competent and ethical nursing practice beyond their primary employment setting.

## 4. Community Service

Nominees in this category will have demonstrated significant professional and/or voluntary contributions in community-based setting or community outreach effort, such as:

- Provided nursing services based on the recognition and identification of patterns of response to actual or potential health problems.
- Demonstrated leadership expertise in a community service setting.
- Committed to the implementation of the Nursing Standards of Care and Nursing Standards of Professional Performance.

## **Community Service continued**

- Demonstrated evidence of advocacy where communities were empowered to attain and maintain wellness.
- Applied clinical decision making that encompassed significant. action taken by nurses in providing care to advance community health.
- Promoted and protected the health of populations using knowledge from nursing, social, and public health sciences based on evidence described.

## 5. Education

Nominees in this category will be nurse educators teaching at any level who have demonstrated significant contributions to curriculum development, teaching strategies or life-long learning of students and junior faculty, such as:

- Demonstrated excellence in teaching.
- Advanced the science of nursing through clarifying, refining, and/or expending the knowledge base for nursing.
- Promoted a theory base for nursing curricula and nursing practice.
- Influenced scholarly development in nursing education, practice, and/or research through teaching.
- Influenced the professional practice of nursing and the public's image of nursing through excellence in teaching.

## 6. Government

Nominees in this category will have made significant contributions, and have made a difference to state, federal, legislative, and regulatory issues, such as:

- Demonstrated expertise in achieving a legislative goal positively impacting nursing and/or health care.
- Influenced the conceptualization, interpretation, and mobilization of support or enactment of significant legislation.
- Achieved the implementation of a public policy to advance the nursing profession.
- Generated a positive impact on state, federal and legislative and regulatory policy.

## 7. Mentoring

Nominees in this category will have provided a positive professional influence by guiding others in their professional development, networking and expanding career opportunities, such as:

- Demonstrated expertise in advancing the personal, professional, and educational growth of mentees.
- Demonstrated effective use of characteristics to facilitate a positive mentormentee relationship.
- Demonstrated advanced skills of communication, continued professional growth and the ability to be supportive.
- Shared resources freely for the growth and development of the individual.
- Maintained the mentoring relationship over time.

### 8. <u>Research</u>

Nominees in this category will be nurse researchers who have completed and published basic research which advances nursing, such as: Funded projects are evidence of excellence.

- Conducted distinguished nursing research.
- Published nursing research findings.
- Documents scholarly works related to nursing theory and/or nursing research.
- Procured funding resources for nursing research.
- Generated nursing research that further expands the case for nursing practice, education, administration, historical perspective, and ethics, for example.
- Incorporated novice nurse researchers in nursing research conducted.

## **NOMINATION AND SELECTION PROCESS**

#### 1. Your Selection:

- a. Choose a Nurse who exemplifies excellence in nursing.
- b. Gather as much information on the Nominee as possible to be thorough.
- c. Information entered in the nomination form and narrative section should be recent from within the past 5 years.

#### 2. Nomination Form:

- a. <u>All fields on the Nomination Form are mandatory</u>.
- b. Once submitted, you will receive email confirmation that your nomination has been received.
- c. Resumes, published articles, copies of nominations for other awards such as hospital excellence awards will not be considered in lieu of the Nomination Form. (DO NOT SUBMIT)

#### 3. Narrative Sections:

- a. We recommend you use a paragraph format bulleting information in guideline section.
- b. There is a maximum of 2 pages, doubled-spaced.
- c. Narrative Section (Give specific, detailed examples why you are nominating this individual based on the Categories below):
  - i. <u>Administration -</u> The Nurse who has demonstrated exception management of nursing and/or patient care services (see additional details in guidelines)
  - ii. <u>Advancing and Leading the Profession</u> A nurse who has strengthened the profession in direct patient care, management, policy or the various levels of teaching or research (see additional details in guidelines).
  - iii. <u>Clinical Care</u> A nurse who has demonstrated excellence in direct care deliver in any clinical setting (see additional details in guidelines).
  - iv. <u>Community Service</u> A nurse who has demonstrated significant professional and/or voluntary contributions in community-based setting or community outreach effort (see additional details in guidelines).
  - v. <u>Education</u> A nurse educator teaching at any level who have demonstrated significant contributions to curriculum development, teaching strategies or lifelong learning of students and junior faculty (see additional details in guidelines).
  - vi. <u>**Government**</u> a nurse who has made significant contributions and has made a difference to state, federal, legislative, and regulatory issues (see additional details in guidelines).
  - vii. <u>Mentoring</u> a nurse who has provided a positive professional influence by guiding others in their professional development, networking and expanding career opportunities (see additional details in guidelines).
  - viii. <u>**Research**</u> nurse researcher who has completed and published basic research which advances nursing (see additional details in guidelines).
